MEMORANDUM OF UNDERSTANDING


This Memorandum of Understanding (MoU) is executed at Kalady on the 6th day of April 2022 between **Adi Sankara Trust, Kalady** represented by the Managing Trustee, K Anand, herein after referred to as the "First Party", which expression, unless repugnant to the meaning and context, shall mean and include their successors, heirs, legal representatives and assigns of the one part.

AND

The **Little Flower Hospital & Research Centre, Angamaly** represented by its Director Fr. (Dr.) Joy Ainiyadan, herein after referred to as "Second party" which expression, unless repugnant to the context or meaning thereof, shall mean and include its successors- in- interest and assigns of the other part.

Whereas, the first party has represented to the Second party that the First party is an Educational Institution at Kalady, that they are desirous of having a health check-up scheme for their students, teaching and non-teaching staff members and to have clinic facility once in a week (preferably on every Wednesday), in order to safeguard the health and well-being of their students and teaching and non-teaching staff and that the second party being closely located to their place, and having all required facilities, they believe that the second party would be an ideal partner to tie-up with for availing of the above facilities.

Whereas the second party based on the representations and desire of the first party has agreed to extent the said facilities to first party on the mutually agreed terms mentioned hereinafter.

Now the parties are desirous of reducing this MoU in writing as per the mutually agreed terms and conditions mentioned below:

Tenure

Subject to the termination clause mentioned hereinafter, this understanding shall come into force with effect from date of execution of this understanding and shall remain in force for a period of two (2) years.

Scope of service

During the tenure of this MoU, the Second party shall extend one of the following health checkup facilities to the teaching and non-teaching staff members of the first party. The Actual cost of the tests for the following checkups are given below:

Executive Health Check up	-Rs. 3800
Diabetic Health Check up	-Rs. 5200
Comprehensive Health Check up	-Rs. 6800
Complete Health Check for women	-Rs. 4500

Both first and second parties have agreed upon a discount of 30% of the above mentioned cost for the above packages to the students, teaching and non-teaching staff of first party.

First party must inform the second party regarding the date for clinic facility at the premises of the first party and shall arrange the room required for the clinic facility and second party will arrange and send **one doctor, one nursing staff and one paramedical staff** for running the clinic against a payment of **Rs.3500/-** per visit by the medical team of the second party.

The First party hereby agrees with the second party that cost of medicines given to the patients shall be collected from the concerned staff/student and that in cases warranting medical tests, admitted treatment etc... the patient shall be either admitted to the hospital of second party or shall be referred to another hospital. Above expenses will be in addition to the other costs if the patient is required to be admitted in second party's hospital for treatment.

The second party hereby agrees with the first party that, accident/emergency cases of first party will be attended on priority and expenses for medical assistance shall be borne by first party and second party will verify the identity by the ID card or specified form issued by first party.

The First party hereby agrees with the second party that, a medical camp for general check up will be organized in every semester at college campus for students and staff. The date shall be agreed by both parties based on maximum participation of students and staff.

Both parties also agreed to conduct health awareness camps for the benefit of students and staff on a routine manner at college campus.

Termination


Either party shall have the right to terminate this arrangement by giving 30 days prior notice in writing to the other without assigning any reason.

Governing law and dispute resolution

The provisions and implementations of this MoU shall be governed by the laws of Republic of India.

All or any disputes, claims arising out of this arrangement but could not be settled by means of dispute resolution meetings shall be resolved by means of arbitration, by submitting the dispute for the arbitration of a mutually agreed sole arbitrator in accordance with the Arbitration and Conciliation Act 1996 as amended or reconstituted from time to time and the proceedings of Arbitration shall be conducted at Emakulum, Kerala, India in English Language.


